vote.

PARKS & RECREATION - Mr. Roger Williams, Chairman

Mr. Williams reported that the community wide yard-sale is scheduled for June 5, 2021.

A motion was made by Mr. Conrad to approve the Special events application for the Duncannon Appalachian Trail Community Festival to be held on August 28, 2021. In addition, approve the closure of High Street between Ann and Cumberland Streets between 8:00AM and 5:00PM. The motion was seconded by Ms. Conrad and passed with a unanimous voice vote.

Abundant Harvest will be using Cooper Field to have Movie Nights on July 2 and August 13, 2021

The Bucktails will be holding the 28th Annual Bucktail Reunion at the Clark's Ferry Tavern from July 30 – August 1, 2021.

A motion was made by Mr. Conrad to approve the Bucktails parade route for July 31, 2021. Market St. from Clark St. to Rachel St., Rachel St. from Market to High St., High St. from Rachel to Clark St., and Clark from High to Market to be closed from 8:30AM until 11:00PM. The motion was seconded by Ms. Conrad and passed with a unanimous voice vote.

Mr. Williams is interested in reviving the Tavern Market.

Mr. Wolfersberger suggested putting information in the Borough Newsletter regarding the rental of Borough parks.

Signs will be made for the park hours at Cooper Field and a gate is being considered.

REVITALIZATION & PUBLIC SAFETY- Ms. Kim Conrad, Chairman

New trash receptacles are being considered for public areas in the Borough.

Resolution # 2021-1 was proposed at the April 20, 2021 meeting.

Water loss and the importance of the water line repair at the 11 & 15 overpass was discussed.

The Refuse truck may need replaced in the near future. Foreman Criley is determining the best options for replacement.

FLEET AND FACILITIES - Mr. Michael Wolfersberger

The plan to replace the roof of the Borough Building may be on hold due to the price increase of materials.

A pre-emptive discussion will take place with the Business Campus as to the future capacity of the Sewer lines that they utilize that run into the Borough Wastewater system.
